

**Prevailing Wage Rate
Ordinance 6.11.18**

WHEREAS, the State of Illinois has enacted "An act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, city or any public body or any political subdivision or by any one under contract for public works, approved June 26, 1941, as amended," being Chapter 820 ILCS 130/1 et. seq. Illinois Compiled Statutes; and

WHEREAS, the aforesaid Act requires that the Board of Trustees of Niles Township investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Niles Township employed in performing construction of public works, for said Niles Township.

NOW THEREFORE, BE IT ORDAINED BY the Supervisor and Board of Trustees of Niles Township, County of Cook, Illinois, as follows:

SECTION 1: To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public body or any political subdivision or by any one under contract for public works, approved June 26, 1941, as amended," the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Niles Township Government is hereby ascertained to be the same as the prevailing rate of wages for construction work in Cook County area as determined by the Department of Labor of the State of Illinois as of April, 2018, a copy of that determination being attached here as Exhibit A and incorporated herein by reference. As required by said Act, any and all revision of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's previous determination and apply to any and all public works construction undertaken by Niles Township. The definition of any terms appearing in this Ordinance which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of Niles Township to the extent required by the aforesaid Act.

SECTION 3: The Niles Township Clerk shall publicly post or keep available for inspection by any interested party in the main office of Niles Township this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.


SECTION 4: The Niles Township Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of worker whose wages will be affected by such rates.

SECTION 5: The Niles Township Clerk shall promptly file a certified copy of this Ordinance with the Secretary of State Index Division of the State of Illinois.

SECTION 6: The Niles Township Clerk shall cause to be published in a newspaper of general circulation within the area a notice stating that the ordinance was adopted, and such publication shall constitute notice that the determination is effective and that this is the determination of the public body.






