

**P R E A M B L E**

WHEREAS, on December 10, 2018 the Supervisor and Board of Trustees examined the projected financial needs of the Town Fund for 2019, and

WHEREAS, based upon the examination referred to above, the Supervisor and Board of Trustees determined on December 10, 2018 the amount to be levied for the Town Fund; and


WHEREAS, a comparison of the total amount to be levied for the Town Fund for said year with the amount extended for said Fund for the preceding year was made and resulted in the December 10, 2018 determination that the amount to be levied for said Fund for the current year will not exceed one hundred four point ninety-nine percent (104.99%) of the amount extended for said Fund for the preceding year.

NOW, THEREFORE, BE IT RESOLVED, by the Supervisor and Board of Trustees of the Township of Niles, Cook County, Illinois as follows:

Section I: That the findings set forth in the Preamble hereof are true and correct and are hereby incorporated by motion.

Section II: That this motion shall be in full force and effect from and after its passage and approval according to law.

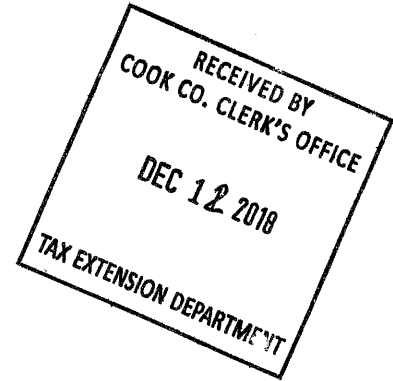



**TAX LEVY ORDINANCE**  
**NILES TOWNSHIP TOWN FUND**  
**ORDINANCE NO. 2018TL/2019**

An ordinance levying taxes for all Town purposes for NILES TOWNSHIP, Cook County, Illinois, for the tax year 2018, collectible in 2019.

BE IT ORDAINED by the Board of Trustees of NILES TOWNSHIP, Cook, County, Illinois, as follows:

SECTION I: That the sum of **two million, one hundred eighty-six thousand, eight hundred and fifty-five dollars (\$2,186,855)** is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Assessor

Social Service Agencies

for the year 2018/2019.

SECTION II: That the amount levied for each object and purpose shall be as follows:




