A RESOLUTION DETERMINING THE 2020/2021 LEVY FOR THE TOWNSHIP OF NILES GENERAL ASSISTANCE FUND WILL NOT EXCEED THE 5% TAX CAP AT ONE HUNDRED FOUR POINT NINETY-NINE (104.99%) PERCENT OF THE FUND EXTENSION FOR THE PRECEDING YEAR

P R E A M B L E

WHEREAS, on December 14, 2020 the Supervisor and Board of Trustees examined the projected financial needs of the General Assistance Fund for 2021, and

WHEREAS, based upon the examination referred to above, the Supervisor and Board of Trustees determined on December 14, 2020 the amount to be levied for the General Assistance Fund; and

WHEREAS, a comparison of the total amount to be levied for the General Assistance Fund for said year with the amount extended for said Fund for the preceding year was made and resulted in the December 14, 2020 determination that the amount to be levied for said Fund for the current year will not exceed one hundred four point ninety-nine percent (104.99%) of the amount extended for said Fund of the preceding year.

NOW, THEREFORE, BE IT RESOLVED, by the Supervisor and Board of Trustees of the Township of Niles, Cook County, Illinois as follows:

Section I: That the findings set forth in the Preamble hereof are true and correct and are hereby incorporated by motion.

Section II: That this motion shall be in full force and effect from and after its passage and approval according to law.



TAX LEVY ORDINANCE
NILES TOWNSHIP GENERAL ASSISTANCE FUND
ORDINANCE NO. 2020 GAL/2021

An ordinance levying taxes for all General Assistance purposes for NILES TOWNSHIP, Cook County, Illinois, for the tax year 2020, collectible in 2021.

BE IT ORDAINED by the Board of Trustees of NILES TOWNSHIP, Cook, County, Illinois, as follows:

SECTION I: That the sum of **Three hundred and sixty - six thousand, eight hundred and twenty dollars (\$366,820)** is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as General Assistance for the year 2020/2021.

SECTION II: That the amount levied for each object and purpose shall be as follows:


