NILES TOWNSHIP TOWN FUND
ORDINANCE NO. 2021TL/2022

An ordinance levying taxes for all Town purposes for NILES TOWNSHIP, Cook County, Illinois, for the tax year 2021, collectible in 2022.

BE IT ORDAINED by the Board of Trustees of NILES TOWNSHIP, Cook, County, Illinois, as follows:

SECTION I: That the sum of **two million, five hundred thirty thousand, eight hundred and thirty - four dollars (\$2,530,834)** is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Assessor

Social Service Agencies

for the year 2021/2022.

SECTION II: That the amount levied for each object and purpose shall be as follows


