

RESOLUTION NO. 2022-11

A RESOLUTION OF NILES TOWNSHIP DETERMINING THE AMOUNTS OF MONEY, EXCLUSIVE OF DEBT SERVICE COSTS, ESTIMATED TO BE NECESSARY TO BE RAISED BY TAXATION FOR TAX YEAR 2022, COLLECTIBLE IN 2023

P R E A M B L E

WHEREAS, the Niles Township ("Township") is a unit of local government operating pursuant to the Illinois Township Code, 60 ILCS 1/1-1 et seq. (the "Township Code"); and

WHEREAS, the Township is subject to the Illinois Truth in Taxation Law, 35 ILCS 200/18-55, et seq. (the "Truth in Taxation Law"), which law requires taxing districts to disclose by publication and to hold a public hearing on their intention to adopt an aggregate levy in an amount more than 105% of the amount of property taxes extended or estimated to be extended, plus any amount abated by the taxing district prior to such extension, upon the final aggregate levy of the preceding year; and

WHEREAS, the Truth in Taxation Law requires that not less than 20 days prior to the adoption of its aggregate levy, the corporate authority of each district shall determine the amounts of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation for that year upon the taxable property in its district; and

WHEREAS, the Supervisor and Board of Trustees of Niles Township examined the projected financial needs of the Town Corporate Fund (the "Town Fund") and the General Assistance ("GA") Fund for the 2023 calendar year; and

WHEREAS, based upon the examination referred to above, the Supervisor and Board of Trustees have determined the estimated amount to be levied for the Town Fund; and

NOW, THEREFORE, BE IT RESOLVED, by the Supervisor and Board of Trustees of the Township of Niles, Cook County, Illinois as follows:

Section I: The findings set forth in the Preamble hereof are true and correct and are hereby incorporated by motion.

Section II: The amount of money, exclusive of levies for debt service and election costs, estimated to be necessary to be raised by taxation by the proposed levy of Niles Township for the 2022 Tax Year (Collectable in 2023) is estimated to be **\$3,061,465.00** (the "Estimated Levy"). A copy of the draft proposed Levy Ordinance is attached hereto and incorporated herein as "**Exhibit A.**"

Section III: The amount of said Estimated Levy for said Tax Year is an **amount less than 105%** of the property taxes extended, or estimated to be extended, plus any amount abated by the taxing district prior to such extension, upon the final aggregate levy from the preceding year.

Section IV: That this Resolution shall be in full force and effect from and after its passage as provided by law.

**AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES FOR NILES
TOWNSHIP, COOK COUNTY, ILLINOIS FOR THE TAX YEAR 2022,
COLLECTIBLE IN 2023.**

An ordinance levying taxes for all town purposes for Niles Township, Cook County, Illinois for the tax year 2022, collectible in 2023.

BE IT ORDAINED by the Supervisor and the Board of Trustees of Niles Township, Cook County, Illinois, as follows;

SECTION 1: That the sum of **three million, sixty-one-thousand, four hundred sixty-five dollars (\$3,061,465.00)** is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

**General Town (Corporate) Fund and
General Assistance Fund**

For the tax year 2022, collectible in 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
